#### **SYNOPSIS**

Estate salespersons and the public alike hold many misconceptions regarding property valuation. One such common misconception is that valuers invent value, that is to say, valuers are at liberty to peg the value of a property without regard to some sort of principles or bases. Yet another is that price is equivalent to value or that an expensively-renovated property must necessarily translate into a high value for that property.

This course seeks to correct such misconceptions and introduce fundamental principles of valuation to estate salespersons so that they can augment their professional competence as a service-provider. Included in the course is a practical session on the application of the Market Comparison Method of Valuation. This will help the course participants appreciate the kind of judgment a valuer needs to apply in undertaking a valuation.
