# **Synopsis of Presentations**

The lectures will explain the updated SISV Valuation Standards and Practice Guide introduced recently. There are 4 separate modules dealing with 4 main aspects of the Guide, namely, General Concept and Requirements including Ethical Duties (**Module 1**); Real Estate Valuation (**Module 2**); Business Valuation (**Module 3**); and Plant and Machinery Valuation (**Module 4**).

How the Guide should be used will be illustrated with examples for each module. A Certificate of Successful Completion will be awarded to those who wish to take a Test on Valuation Standards and Practice Guide (1 hour test with 100 MCQs) at the end of the 4 modules on 09 March 2016 (7.00pm to 8.00pm).

### Topics covered in each module:

**Module 1**- core competencies; professional ethics; purposes of valuation; conditions of engagement; conflict of interest; limiting conditions

**Module 2** – real estate valuation general concepts and principles; market value basis; valuation other than market value; approaches and methods of valuation; property inspection and referencing; valuation report; revaluation

**Module 3** – business valuation general concepts and principles; fair market value basis; defining and describing business interest; valuation report; approaches and methods of valuation; valuation of intangible assets, valuation for financial reporting

**Module 4** – plant and machinery valuation general concepts and principles; fair market value basis; classification and referencing; valuation report; approaches and methods of valuation.

Who Should Attend Practising valuers and those probationers who are going for their Test of Professional Competence Interview, and others who wish to learn more about valuation standards. In view of the demand for these lectures, the initial courses for the scheduled date will only be offered to SISV VGP members who are practicing valuers and probationers.
