## **Singapore Reveals New Findings in Spatial Technology**



Spatial technology is becoming increasingly ubiquitous in the world today. Singapore was privileged to share its innovative use of GPS technology at the South East Asian Survey Congress which was held in New Zealand from 30th October to 2nd November 2007.

The South East Asian Survey Congress is a biennial forum for nations in South East Asia to share experiences in the research and application of spatial technology. The Honorable David Parker, New Zealand Minister for Land Info & Acting Minister for the Environment outlined the theme for this year's congress, "Developing Sustainable Societies" in his opening address on

"Land Management in Support of Sustainability and the Global Agenda".

Mr Victor Khoo from Singapore presented a paper on the use of real-time GPS readings to carry out structural monitoring. The presentation introduced the recently launched Singapore Satellite Positioning Reference Network (SiReNT), which supports various Differential GPS (DGPS) positioning businesses and industries. The paper outlined the results and learning points from a recent proof of concept test to show the feasibility of using VRS-RTK technique for structural monitoring.

Mr See Seng Guan was invited to chair a session on "GIS and the Sustainable Environment".

### **INTER-PROFESSIONAL GAMES 2007**

The Inter-Professional Games for 2007 was organised by the Singapore Medical Association, and teams from the following institutions took part:



## **Land Surveying Equipment Took** the Spotlight at IES Academy

On 20th October 2007, Institute of Engineering Singapore (IES) invited Land Surveyors Board (LSB) member, Mr Tan Choo Haw and Dr Tor Yam Khoon, Associate Professor of School of Civil & Environmental Engineering (CEE) in Nanyang Technological University of Singapore (NTU) to share their expertise on the developments in the field of land surveying - specifically on the Universal Transverse Mercator Projection (UTM) and the 3D Terrestrial Laser Scanning (3D LTS).

Besides giving an overview UTM and its various approaches to measurements, Mr Tan also introduced the latest technology in 3D LTS used in Time of Flight and Phase Comparison laser scanners.

Dr Tor, on his part, highlighted recent breakthroughs in the field of laser Breakthroughs which allowed scanners such as Leica Geosystems Truview to extract real 3D coordinates of the scanned subject to



measure distances more accurately. With 3D LTS, point cloud data can now be better transformed into a 3D model of the scanned subject using Autocad or other 3D softwares.

## The importance of effective communication and clarity

A common thread ran through the two talks that were held at Furama City Centre on the 26th October 2007 - that of clarity and the importance of effective communications.

In the first part of the seminar

entitled 'Design & Build: Novation or Consultant Switch' Ms Eugenie Lip, Head of KPK Contracts Support Group addressed the controversy that often came about when the design intent of a design-build project was not effectively understood or specified to the rest of the parties involved. Professional advice is thus encouraged in order to avoid ambiguity. Ms Lip also highlighted the pros and cons between a novation and consultant switch that participants should consider in a design-build project.



After a short networking break, second speaker Mr Chov Chee Yean. Partner and Deputy Head of Projects & Infrastructure Group at Rajah & Tann talked on the developments in construction law citing examples of legal cases from around the world. Similarly, clarity remains the crux of each design-build project where the parties involved need to effectively understand the terms and agreements of a binding contract before they sign on the dotted line.



## SOPA cleans up late payments acts in the Building and Construction Industry

It may still be early days for Security of Payment Act (SOPA) since it came into effect on 1st April 2005. However, fast-forward three years on, SOPA has continued to grow from strength to strength in its relevance to help speed up cash flow and payments for the local building and construction industry.

On 23rd November 2007, SOPA Chairperson, Mr Joseph Liow, Director of Straits Law Practice LLC, Advocates & Solicitors gave an informative talk at Furama City Centre on adjudication: a dispute-resolution process that is 'quick, inexpensive and efficient'. Previously, without SOPA,

industry players were often plagued with cash flow problems that result in many project failures due to late payments by the owners or the claimants had to undergo a lengthy arbitration process - something that did not help alleviate their cash flow problems.

Mr Liow citied a few examples of cases before he opened up the floor for a short Question & Answer session.
