A Restatement of the Penalty Doctrine in Commonwealth Jurisdictions

About this Seminar:-

The law of penalties, which is highly relevant in a variety of ways to the practice of construction law, has recently been the subject of significant judicial consideration in Australia. In *Andrews v ANZ* [2012] HCA 30, the High Court of Australia brought down a beautifully crafted judgment setting out the history of the law of penalties and restating the doctrinal basis for this peculiar area of the law. This talk will explore this doctrinal basis, analyse the decision in *Andrews* and provide commentary as to the further development and application of the doctrine. It will also consider some ramifications for drafting both LD clauses and other common provisions in construction contracts which could be construed as being "penal" (eg an abatement regime in a public private partnership deed). The decision in *Andrews* is pertinent because it traces the origins of the doctrine back to its English roots and, as such, provides a fascinating retrospective for all common law jurisdictions
