## QS Seminar, 22 January 2016

#### Chairman:

Dr Chan is AlAJ's Co-Editor and the Editorial Advisory Board member and Correspondent of the *International Construction Law Review*. He is a practising arbitrator and a Fellow of SIArb. Dr Chan has written twelve books as sole or co-author and had contributed articles to international construction law journals. He has delivered more than 200 conference/seminar papers and conducted numerous in-house training programmes on safety and health law, construction law, arbitration and adjudication.

## **Synopsis**

VO and EOT clauses have become permanent features in standard forms of and ad hoc building and construction contracts. In the failure to provide a comprehensive scope for these clauses, the courts will be guided by the principles of common law. The speaker will review some of the common omissions. Further, with the enactment of the SOP Act, which adjudicates payment claim disputes only as compared to the UK position where all disputes may be submitted for contractual adjudication, the speaker will examine the relevant local statutory provisions relating to the scope of claims to determine whether and to what extent VO and EOT claims and related claims may be adjudicated in Singapore. Finally, an evaluation of the VO and EOT clauses in SA and PSSCOC will be made in respect of adequacy of provision.
