Mr Anil Changaroth will discuss how the ancient principles of *Sun Tzu* may have its modern day applications in managing Construction issues & disputes.

Session 2:

There are many misconceptions amongst construction industry practitioners about the scope of CAR/TPL and WIC insurance coverage and how it should be specified in tender/contract documents. In this session, **Mr Choy Wing Kwong** will discuss these issues from the perspective of the insurance industry with the objective of promoting dialogue with construction industry practitioners.

A broad range of issues will be discussed including:

- third party liability limits, how much is "enough"?
- the non-negligence clause, is it still required?
- professional fees and debris removal limits
- waiver of subrogation
- who are the insured parties and the extent of cover for consultants as insured parties
- deductible levels
- the function of wageroll in Work Injury Compensation insurance

Anil Changaroth is currently a partner with Aequitas Law LLP, having been in practice since 1995 after graduating as a Barrister of England and Wales (Middle Temple), following a 5 year career as an infantry officer with the Singapore Armed Forces. His work primarily involves commercial, civil, corporate & criminal litigation and dispute resolution with a focus on Construction, Infrastructure & Arbitration.

Anil represents parties in Singapore and the region including Australia, Sri Lanka, Hong Kong, India, Indonesia, and Pakistan with Construction Disputes Resolution (in the areas of adjudication, arbitration, litigation & mediation); Civil, Commercial Dispute Resolution and Criminal litigation including Contractual & Debt recovery claims; Banking & Factoring; Bankruptcy; Commercial & Property management corporation disputes; Conveyance; Hire Purchase & Leasing; Employment; Defamation; Insurance; Personal Injury (Medical Negligence, Accident & Insurance); Matrimonial (civil & Syariah Courts) and Adoption; Estate, Wills, Trust & Probate (contentious and non-contentious); and Criminal matters (Penal Code & other Statutes); Corporate Litigation including Liquidation, Winding Up & Schemes of Arrangements; Corporate Advisory work including drafting of front-end Construction & Infrastructure contracts, Tenancy, Partnership, Shareholders, Joint Ventures, Share Capital Reduction and Buy-Back and other agreements.

Prior to joining Aequitas in 2009, Anil spent a year with the international arbitration practice group at the international law firm of Lovells Lee & Lee and two years before that as in-house counsel, director and head of Contract Advisory and Dispute Management Services of the quantity surveying firm Davis Langdon & Seah Singapore Pte Ltd.

A Fellow of the Chartered Institute of Arbitrators (CIArb) and the Singapore Institute of Arbitrators (SIArb), Anil is honorary legal advisor to the Singapore Institute of Architects (SIA) advising the Small & Medium Architectural Practices (SMAP) Committee (including on the SIA Minor Works Standard Form Contracts 2012) and is on its panel of Construction Lawyers, is the Honorary Treasurer of the Singapore Institute of Arbitrators [2011-2013] and chair of its Schemes Arbitration committee and the Chairman of the Society of Construction

Choy Wing Kwong trained as a quantity surveyor in Australia. During his time there he was awarded the Australian Institute of Quantity Surveyors Post-Graduate Research Fellowship. He subsequently worked for 8 years as a quantity surveyor and as a project manager on major construction projects in Australia and in Singapore.
