#### Seminar Outline/Speakers

# (Session 1) Contract and Cost Management on large, complex, fast track projects – Potential pitfalls and successful solutions

On every major project there will usually exist a Project Execution Plan or Procedures' Manual that clearly outlines roles and responsibilities, workflows, costs and change control authorisation procedures, usually accompanied with a myriad of diagrams and standard templates for the Project Team to follow. These best practice tools are generally well thought out and in place for every project. Why is it then that projects still struggle with time and budget overruns?

Why is it that in times of pressure and crisis, procedures and best practice are difficult to follow? What are the pitfalls to look out for? How do we go about avoiding them? What are there critical success factors in contract administration we need to consider to ensure that project goals of time, cost and quality are met? In the face of crisis and uncertainty, what are the key skills administrators need to possess, other than insistence on strict adherence to procedures that may be impractical or too time consuming to implement?

We will look at attempting to answer these questions by examining a case study of a recently completed large scale complex project in Singapore and look at the practical solutions adopted to successfully navigate these problems.

**Colin** is a South African and worked in the construction and mining industry prior to joining the Hong Kong office of RLB in 1993. His 24 year career in the industry has been characterised by very large, fast track and challenging high profile projects. He has been responsible for the provision of complete QS services from project inception to completion for major commercial, institutional, hospitality and entertainment developments including the Hong Kong Convention and Exhibition Centre Extension, the IFC building in Central Hong Kong, the Venetian Sands Casino and the Venetian Integrated Resort projects in Macau.

It was the Macau connection that brought Colin to Singapore and he joined the RLB Singapore practice in 2007 as the QS Project Director for the Marina Bay Sands IR Project. He was involved from day one through to final account settlement and together with the Project team, was instrumental in ensuring that the project that was completed on time and within budget. Apart from quantity surveying, Colin has also been responsible for the development and provision of Specialist Services encompassing project management, value management, dispute resolution, arbitration support, delay and quantum analysis.

# (Session 2) Limitation periods in the context of claims in the construction industry

Chien Mien will be speaking on the important topic of imitation periods in the context of claims in the construction industry, and specifically on:

- ⇒how limitation periods affects claims,
- ⇒how they arise,
- ⇒how they are calculated,
- ⇒how they can be extended under the law and
- ⇒how parties may agree to extend limitation periods

**Chien Mien** graduated from Bristol University with an LLB (Hons) degree in 1989. He qualified as a Barrister-at-Law at Gray's Inn in 1990 and was called to the Singapore Bar in 1991, when he joined Allen & Gledhill. He became a Partner in Litigation & Dispute Resolution in 1997. He is an Accredited Adjudicator with the Singapore Mediation Centre. He is also a Fellow of the Singapore Institute of Arbitrators and Accredited Arbitrator under the Law Society Arbitration Scheme

Chien Mien's areas of practice encompass a wide range of contentious and non-contentious work in the areas of construction, engineering and infrastructure projects. His experience in contentious matters includes disputes relating to power, utilities, desalination, petrochemical and manufacturing plants, water treatment facilities, roads and tunnels, dams and waterways, mass rapid transit projects, sports complexes, aircraft hangers, major office buildings, retail malls, hotels, condominiums, and specialised warehouses.

Chambers Asia (2009) commends Chien Mien as being "(t)he obvious choice for building and construction work" and for being "really savvy from a commercial and legal point of view". According to Who's Who Legal Singapore (2008), Chien Mien "is known for his 'formidable' litigation, arbitration and mediation experience, both at home and abroad". The Asia Pacific Legal 500 (2007/2008) notes that "construction specialist Ho Chien Mien has a solid reputation" and that he "continues to be a leading light in construction disputes".
