The International Valuation Standards (IVS) 2017 was introduced by the International Valuation Standards Council (IVSC) in December 2016 to be implemented from 1 July 2017. IVSC signed a Memorandum of Cooperation with WAVO (World Association of Valuation Organisations) in November 2016 for WAVO to undertake education and training on IVS to valuers around the world.

SISV is pleased to organise this one-day workshop for WAVO lecturer to conduct the IVS 2017 to our members. This is a workshop for only SISV valuation members to acquaint themselves with the new world standards.

Learning Objectives: To introduce all the requirements of IVS 2017 to participants. This includes the general valuation standards, and standards relating to the valuation of the key assets, namely, business, intangible assets, plant and equipment, real estate interests and financial instruments.

Learning Outcomes: Participants should acquire a good appreciation of the various requirements of the international valuation standards, and be able to conduct their valuations in compliant with the IVS 2017.

Introduction to IVS 2017 and general standards relating to scope of work, investigations, compliance, reporting, bases of value and approaches and methods of valuation as well as valuation of business interests.

Afternoon

Standards relating to intangible assets, plant and equipment, real estate interests and financial instruments.

Participants who take and pass the test at the end of the course will be awarded the Completion Certificate issued by WAVO.
