About APQS Scheme

- The APQS designation, a SISV Industry Transformation Initiative, ensures that Quantity Surveyors practising in Singapore are competent, dedicated to maintaining the highest standards of professional service excellence and seek continuous improvement and development.
- Endorsed by the Central Procurers Panel, APQS is 1 of the 8 Accreditation schemes for Built Environment Sector professionals, and a building block of the eventual competency-based procurement for public sector construction and FM procurement.
- When a critical mass of accredited personnel is built up, the APQS credentials, will be recognized as the **default requirement** for consulting and contracting services for public and private sector projects.
- Quantity Surveyors, SISV members and non-members alike, are encouraged to apply for APQS accreditation as soon as possible.

Benefits of Accreditation for QS Professional & the Built Environment

- APQS scheme defines the desired workforce skills standards and training needs for QS Professionals. The clarity in progression milestones and skills requirements will help QS Professionals to chart their career development
- Independent validation of skillsets differentiates APQS from other QS Professionals in the industry. The esteem and pride associated with APQS will help retention and bolster standards and professionalism in the Built Environment
- Renewal of Accreditation requires APQS to fulfil Continuing Professional Development (CPD). This motivates registrants to continually learn and progress.
- Higher pay will follow upskilling through continuing education and training
- Use of Post-nominal letters. Successful applicants may use the post-nominal letter of APQS TierX and may use the term Accredited Professional Quantity Surveyor.


Who can apply for APQS?

APQS Applicants do not have to be SISV members but must be currently undertaking Quantity Surveying work and is in good standing¹.

APQS & SISV Membership

Non-Member APQS applicants are strongly encouraged to apply for SISV membership. SISV will waive membership processing fee when membership & APQS application are submitted together.

¹Status of registration with a Professional QS Institution is not "suspended" or "delisted" and has paid all membership fees or a person who is of good character and is trustworthy.

APQS Renewal

- APQS Accreditation is valid for 1 year only. Continuing Professional Development is mandatory for renewal of APQS Accreditation.
- APQS of ALL Tiers, must attain a minimum of 20 CPD Units over the renewal qualification period (12-month period immediately preceding the application of renewal).
- Route 3 Applicants who rely on their professional memberships for their APQS application, must continue to remain as a member of that Professional QS Institute when they apply for annual renewal.
