The Accredited Professional Quantity Surveyor (APQS) Designation

A. Introduction

Singapore's nation building programme is heavily focused on developing world class, functional, value for money facilities and infrastructure. In this regard, Quantity Surveyors in Singapore have an important part to play in serving the public, in ensuring that both private development and national infrastructure spending budgets are robust, yet prudent and that there is impartiality, transparency and accountability in the spending of private and public funds.

The APQS Designation, is a SISV Industry Transformation Initiative, to ensure that Quantity Surveyors practicing in Singapore are **competent**; dedicated to maintaining the highest standards of **professional service excellence**; and seek **continuous improvement** and development.

More importantly, it is SISV's benchmark to ensure the public and Supporting Employer Organisations that APQS's display **Integrity by being accountable, transparent, fair and impartial**. Whether in the public or private sector, **Integrity** is the core value and the foundation upon which the mission, goals and beliefs of the Public Service or Professional Governance are built. Integrity is key to the governance principle of **Incorruptibility**.

The Ministry of National Development has formally supported this self-regulation initiative. It is in line with the Singapore Building and Construction Authority (BCA) mandate for greater professionalism and professional workforce productivity in the Built Environment.

The APQS designation sits within the Accreditation Framework of the **BCA Skills Framework for the Built Environment (SFw)**. The BCA recognises the professional standing, value and benefit of the APQS designation - that APQS's are recognised by the community, industry and government as a professional and responsible contributor to the industry.

The APQS designation serves to give a high level of confidence to clients and supporting employer organisations that APQS's are bound to the high professional standards including **a Code of Professional Conduct** and are **Responsible & Accountable** for the services that they provide.

The SISV QS Division will ensure that an APQS:

- 1. Has satisfied stringent entry requirements in terms of having recognised university degree and qualifications;
- 2. Has sufficient, relevant, approved, local post-graduation practice experience;
- 3. Has successfully passed an Assessment of Professional Competence conducted by SISV QS Division; and
- 4. Has sufficient Singapore professional practice experience to provide services and advice to clients.
- 5. Understands that he or she is:
 - a) Bound by a Code of Professional Conduct, which centres on:
 - Providing services of a high standard with care, efficiency, competence, confidentiality, fidelity and diligence;
 - Integrity, Fairness and Impartiality.
 - b) Subject to disciplinary actions should he or she contravene the above; and
 - c) Committed to excellence and currency of knowledge through the requirement to fulfil on-going Continuing Professional Development (CPD) to maintain their accreditation.

The APQS designation represents the highest level of expertise within the Singapore QS profession. It is an optional additional designation to the SISV Professional Membership grade. It does not change the membership grade but provides clients an additional assurance of the consultants' level of expertise.

2. Accreditation – The APQS Framework

SISV has been designated by BCA to develop the QS Accreditation scheme in alignment with the SFw and Accreditation Framework. Subsequently, the APQS framework has been endorsed by the Central Procurer Panel to be administered by SISV. SISV will:

- be the formal accreditation body for the Quantity Surveying profession; and
- administer the endorsed accreditation scheme.

The Accreditation scheme comprises four Tiers as indicated above. The Proficiency Level/ Competency required for each Tier is detailed in each Skills Map.

3. Procurement

The Tier of Accreditation will be a future procurement benchmark for Quantity Surveying services



in Singapore and will be adopted by Supporting Employer Organisations.

4. Who can apply?

One of the Key Principles of the Accreditation scheme is Inclusivity, and applicants <u>do not have to</u> <u>be</u> SISV members but must be currently undertaking Quantity Surveying work, and are in Good Standing.

Application for the APQS designation is available to:

- New applicants to SISV Membership/ APQS registration
- SISV Members
- Non SISV Members who are Professional members of other equivalent international recognised Professional Quantity Surveying Institutions and who have successfully passed an Assessment of Professional Competence
- Non-QS degree individuals who can demonstrate compliance with the Skills Framework requirements for Tier 4

An APQS applicant, in Good Standing, must be a person who is of good character and is trustworthy, or, a Member of Professional QS Institution whose status of registration is not "suspended" or "delisted" and has paid all membership fees.

All applicants should not have substantial breach of any SISV, or equivalent international recognised Professional Quantity Surveying Institution, Code of Conduct in the past 2 years.

Applicants with a complaint in progress regarding a breach of any QS Code of Conduct, will have their application for APQS designation deferred until the outcome of the complaint has been determined.

D. Requirements for all Tiers:

- 1. Complete the APQS Application Form.
- Complete the Competencies Reports for Tier 1 / 2 / 3 / 4, demonstrating required years of professional experience or knowledge (include description of specific role/s within project/s worked on).
- 3. Complete and sign the declaration confirming compliance with the Institute's Constitution, Bylaws, Rules for maintaining the Accredited Professional Quantity Surveyor designation, and Code of Professional Conduct of SISV QS Division.
- 4. Be currently engaged in the practice of Quantity Surveying.
- 5. Pay the application fee.
- 6. Pay any outstanding SISV membership arrears, if applicable.
- 7. Successfully complete an APQS Interview as required.

Typical time taken is 8 – 12 weeks. The application process could take longer, depending on the number of APQS Application received by SISV.

F. APQS Application Fee, Interview Fee and Annual Fee

- 1. All fees are payable in Singapore dollars SGD.
- 2. All fees quoted below exclude the applicable prevailing GST.
- 3. Application fee is non-refundable and must accompany the Application Form for APQS designation.
- 4. Interview fee is payable when APQS interview is arranged.
- 5. The APQS designation is valid for a period of 1 year, subject to an annual Fee.
- 6. Upon successful registration APQS, SISV will collect pro-rata annual fee for first partial year of APQS designation,
- 7. For subsequent renewal of APQS designation, full annual fee will be collected

H. Assessment

Applications for APQS designation will be assessed by a minimum of 3 Panel Assessors, with a minimum of 2 Panel Assessors' endorsements for the APQS designation to be awarded. Normal conflict of interest rules applies. If the APQS applicant is a member of the SISV QS Council, all the QS Council members cannot be members of the assessment panel for the applicant.

Determination of Accredited Professional Quantity Surveyor designation is assessed on an individual basis and is at the sole discretion of the SISV QS Council.

I. Appeals Process

Applicants have the right to appeal an APQS designation decision in accordance with the <u>appeals</u> <u>process</u>.

J. Use of designation

Successful applicants may use the post nominals APQS following their standard SISV membership post nominal (for example MSISV, APQS), and may use the term Accredited Professional Quantity Surveyor.



K. Maintaining Accredited Professional Quantity Surveyor Designation

A breach of the SISV QS Code of Professional Conduct may result in removal or suspension of the APQS designation. Other disciplinary actions in accordance with the <u>APQS Disciplinary Process</u> may also apply.

Unauthorised and/or inappropriate use of Accredited Professional Quantity Surveyor (APQS) designation can lead to prosecution.

APQS's must maintain the prescribed level of Continuing Professional Development (CPD). Breaches may result in removal or suspension of the members APQS designation. The prescribed level of CPD for an APQS designation is the level of CPD expected for a SISV Professional Member as outlined in the SISV Continuing Professional Development Framework (currently set at **20 CPD hours** per annum.).

APQS's are required to update their CPD record annually by December 31 in compliance with the SISV Continuing Professional Development Framework. APQS who are SISV Members can update their CPD record via the SISV member portal website under the Events & CPD page.
